A resolution to make appropriations; to provide for the expenditure of the appropriations; and to provide for the disposition of all income received by Hope of Detroit Academy.

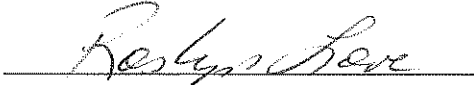

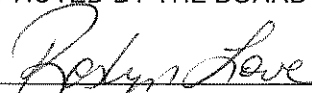

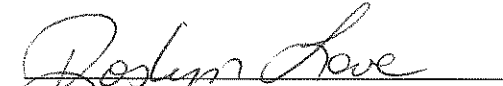
